Amusement Devices (per device)	\$500.00
Arcade Games (per device)	\$25.00
Juke Box (per device)	\$15.00
Pool Table (per device)	\$30.00
Each Bowling Lane (per device)	\$15.00
Carnivals -- \$150.00 per day or any part thereof or \$600.00 per week, plus (\$50.00) per day for every food concession or mechanical or nonmechanical ride	
Circuses -- \$250.00 per day or any part thereof, as well as \$75.00 per day for water used and consumed on the premises, together with a cash bond in the sum of \$300.00 at the time of application for the purpose of indemnifying the City for any cleanup costs incurred on the premises used by the circus. If no cleanup is required by the City, the bond shall be returned.	
Dances -- As follows: One day - \$5.00 One week - \$10.00 One month - \$20.00 One year - \$150.00	
Fairs -- \$150.00 per day or any part thereof or \$600.00 per week, plus \$50.00 per day for every food concession or mechanical or nonmechanical ride	
Festivals -- \$130.00 per day or any part thereof or \$600.00 per week, plus \$50.00 per day for every food concession or mechanical or nonmechanical ride	
Movies -- \$100.00 per month per screen	
Shows -- \$50.00 per day	
Mechanical riding devices -- \$25.00 per device per year
